DIVIDED INTO 2 PARTS

- IC 33-38-9.5-1- "Local or regional advisory council"
- IC 33-38-9.5-4- Establishes local advisory council



- IC 33-38-9.5-2- Community Corrections Code Provision
- JRAC review & recommendations to improve operations with EBP

LOCAL ADVISORY COUNCIL

- IC 33-38-9.5-4- "Local or regional advisory council"
- Membership- Chief PD/PD, Prosecutor, CMHC, Sheriff, CC Director, CPO, President Commissioners, President C. Council, Circuit Judge(or selected)
- Leadership- annual election of chair/vice chair
- Meet Quarterly (Minimum)
- IC 33-38-9.5-4-9 (d) The community corrections advisory board may vote to serve as LAC
- Section 4-5- Promote: use of EBP, community alternative & programs: probation, PSC, MH Services, PT, CC, EB programs for incarcerated, other rehab alternatives, EBP for jail overcrowding

HEA 1068

LOCAL ADVISORY COUNCIL

- IC 33-38-9.5-6- Duties: (1) Review, evaluate, and make recommendations for local: (A) criminal justice systems and corrections programs; (B) pretrial services; (C) behavioral health treatment and recovery services; (D) community corrections; and (E) county jail and probation services.
- (2) Promote state and local collaboration between the advisory council and the local or regional advisory council.
- (3) Review and evaluate local jail overcrowding and recommend a range of possible overcrowding solutions.
- (4) Compile reports regarding local criminal sentencing as directed by the advisory council.

HEA 1068

LOCAL ADVISORY COUNCIL

- IC 33-38-9.5-6-(5) Establish committees to inform the work of the local or regional advisory council.
- (6) Communicate with the advisory council in order to establish and implement best practices and to ensure consistent collection and reporting of data as requested by the advisory council.
- (7) Prepare and submit an annual report to the advisory council not later than March 31 of each year.

HEA 1068

REVIEW-COMMUNITY CORRECTIONS CODE PROVISIONS

- IC 33-38-9.6-(a) The justice reinvestment advisory council established by IC 33-38-9.5-2 shall conduct a review of community corrections code provisions in the Indiana Code and make recommendations to improve operations with evidence-based practices.
- (b) The justice reinvestment advisory council shall submit a final report containing its findings to the department of correction not later than December 1, 2021.
- (c) This section expires January 1, 2022.
- IC 33-38-9.7- An Emergency is declared in this act.
