Chad Professional Training, LLC. dba Tall Cop Says Stop This session will highlight clothing used to conceal "your valuables" - from stash hats, shirts, shoes and other clothing items to false containers, compartments, and much more. This educational session will be packed with information about common locations, and where to purchase these items, including the Internet. This is important for anyone who deals with stash compartments, including: educators, school administrators, probation officers, correction officers, and anyone suspecting drug use.

# **HIGH IN PLAIN SIGHT - CURRENT ALCOHOL AND DRUG TRENDS**

PROFESSIONAL DEVELOPMENT

Jermaine Galloway, CEO The Tall Cop - J. Chad Professional Training, LLC. dba Tall Cop Says Stop This workshop will provide attendees with the ability, knowledge and confidence to help prevent and identify individuals who are abusing drugs and/or alcohol. Attendees will also be taught the strategies and different terms that are consistent with alcohol & drug abuse. There are several identifiers, logos and terms that are commonly related to drug (illegal and over-the-counter) and alcohol abuse, marijuana abuse, and drug concealment on school, home, and work property.

This session is unique, in that it provides over 70 visual aids through photos and videos. In today's culture, everything is person-specific and has different meanings to different individuals. Meanwhile, certain items have gained popularity in the alcohol and drug scene - which changes every day.

This workshop covers alcohol and drug clothing, alcoholic energy drinks, prescription drug abuse and misuse, alcohol and drug concealment methods and containers, drug paraphernalia, drug related music and groups, logos, stickers, new technology, youth party tendencies, party games, non-traditional alcoholic beverages, social networking sites, synthetic drugs, OTC drugs, inhalants, marijuana concentrates, E-cigarettes, and popular party drugs, including opioids, Adderall, and ecstasy. This session also covers common stash compartments that can be used to hide weapons inside everyday clothing containers and other items, in addition to the impact on traffic safety. In addition, the Tall Cop reviews the emerging trends of Xylazine, legal "gas station heroin" products, and Opioids.

Attendees of the High in Plain Sight presentation, will be able to:

- Quickly identify alcohol and drug use and abuse indicators of possible at-risk individuals, through products, stash compartments, clothing brands, lingo, emerging drugs, etc.
- Recognize the current drug culture at first observation or interview, including Delta 8 and 10
- Identify concealment methods for alcohol and drugs in the classroom or workplace, including vaping
- Provide education for improved policy and procedures regarding current alcohol and drug abuse prevention and intervention
- Recognize area specific alcohol and drug abuse information and content in relations to trends, culture and identifiers.

- Learn the difference between a Sequential Bail Overview and a Jail Overview and the value of both to your criminal justice system.
- Learn how to collaboratively develop a jail review process that aligns with the unique needs of your county.
- Learn tips on accessing and tracking jail data, strategies for effectively conveying information to key stakeholders and how to identify change targets for your Local JRAC and Pretrial Team.

Participants will better understand the impact that stress and trauma have on the brain, body, and outcomes. Participants will better understand the importance of regulation and self-regulation.

VA's highest clinical priority is Veteran suicide prevention. But we can't do it alone. Everyone has a role to play in keeping Veterans healthy and safe. And it starts in your community. Why communities are critical in preventing Veteran suicide?

Approximately half of Veterans receive care outside VA. VA is dedicated to reaching all Veterans where they live and connect. To do this, VA and communities are coming together to implement the public

health approach, combining community and clinical interventions for suicide prevention. Together, VA and communities can work toward ending Veteran suicide.

This workshop will focus on what communities can do to partner with our community engagement and partnership coordinators to enhance suicide prevention efforts.

It will also provide education about the COMPACT Act including Veteran benefits, eligibility and services provided, and discuss continuity and collaborative care with community hospitals/facilities.

# Bridgette Collins-George, Director / PREA Contract Auditor for Department of Justice – Hendricks County Community Corrections

Implicit bias awareness is about eliminating discriminatory behavior and creating genuine inclusive environments. Every aspect of human life is enveloped in culture, from our racial makeup, where we live, our ethnicity, the work we do and the moral beliefs we value.

The purpose of this training is to shine the light on subtle everyday situations wherein mental short cuts perpetuate stereotypes, thus keeping our blind spots intact. If the goal is do better, we must be committed to learning new information and unlearning old thoughts.

People hold biases toward others, organizations and the people they serve that shape decision making and social behavior.

For healthcare providers, corrections, law enforcement, educators or other public-serving organizations, these biases can be harmful or lethal. They endanger careers, clientele and the public.

For private organizations, they can mean lost revenue or profits, decreased team performance, and worse. Given time, these biases can become systemic and structural.

Bias awareness can help managers and workplace leaders understand the need for further cultural change, inclusion, understanding, and diversity.

# **IOCS PROGRAMS AND GRANT OPPORTUNITIES**

This session provides an overview of the Indiana Judicial Branch, covering the state's court structure, the Office of Judicial Administration, and the Office of Court Services. It explores key initiatives, including problem-solving courts, the Interstate Compact system, and pretrial services. Importantly, the presentation details grant programs for problem-solving courts and pretrial agencies, along with juvenile diversion and community alternatives, offering valuable information on funding opportunities, eligibility, and application processes.

# LICENSE SUSPENSION AND REINSTATEMENT

# DISCUSSING MANIPULATION AND DE-ESCALATION IN THE CORRECTIONS SETTING

### RESIDENTIAL

- Review what constitutes a mental illness and the most common psychiatric diagnoses seen in residential/correctional settings.

# **QPR SUICIDE PREVENTION**

## PROFESSIONAL DEVELOPMENT

### Michelle Zaremba, MSW, LSW; Mental Health America - Wabash Valley Region

Question, Persuade, Refer. Three steps anyone can learn to help prevent suicide. Just like CPR, QPR is an emergency response to someone in crisis and can save lives.

The QPR mission is to save lives and reduce suicidal behaviors by providing innovative, practical, and proven suicide prevention training. We believe that quality education empowers all people, regardless of their background, to make a positive difference in the life of someone they know.

According to the Surgeon General's Nation Strategy for Suicide Prevention (2001), a gatekeeper is someone in a position to recognize a crisis and the warning signs that someone may be contemplating suicide. Gatekeepers include parents, friends, neighbors, teachers, ministers, doctors, nurses, office supervisors, squad leaders, foremen, police officers, advisors, caseworkers, firefighters, and many others who are strategically positioned to recognize and refer someone at risk of suicide.

As a QPR-trained Gatekeeper you will learn to:

- Recognize the warning signs of suicide
- Know how to offer hope
- Know how to get help and save a life

# SUD TREATMENT - HOW DO YOU COMPARE TO "BEST"?

#### PROFESSIONAL DEVELOPMENT

### Dr. Michael Miller, CEO & Medical Director – Miller Care Group

Despite significant amounts of dollars, man hours, and research directed at treatments for substance abuse in all its incarnations, there remains minimal uniformity in the delivery of the spectrum of care. While the concept of medication assisted treatment (MAT) is universally accepted as the gold standard, specifics regarding what this concept actually means have themselves not achieved a universal definition. At its most basic, MAT implies access to, utilization of, and participation in identifying specifics of what substances are used (either as primary or secondary, mental and behavioral health counseling to identify underlying and related issues, psychiatric medical management when required to address secondary diagnosis and lastly, the creation of a client specific program to include addressing other related factors (people, places and things).

In stark contrast, these most basic components rarely exist collectively leading to increasing rates of recidivism, and deaths. The criminal justice system has been forced to juxtapose cost restraints with what is identified to them as SUD care.

There are a myriad of concepts for treatment but the basics of best practices for the compendium of SUD have yet to be truly identified and this gap has led to overall failure across the entire spectrum of SUD treatment both in the civilian and criminal justice system.

This program will identify what are considered best practices across the spectrum of SUD and discuss specific theories, programming and treatments and theories for which the SUD treatment community is not aware of, not using, or not using appropriately.

# THE CBT MARKETPLACE - QUICKLY CONNECTING CLIENTS WITH INTERVENTIONS AND COMMUNITY PARTNERS

Do your justice involved clients routinely struggle to connect with beneficial services and assistance during supervision? Quality intervention and supports are an important part of successful community supervision. Facilitating those connections early on is key to ensuring that your justice-involved clients are addressing the criminogenic thinking and risky behaviors that got them in trouble in the first place. Allen County Community Corrections established their CBT Marketplace in 2016 to accomplish just that. This workshop outlines the history and purpose of establishing ACCC's CBT Marketplace, their risk-divided CBT interventions, the integral community partnerships that support the marketplace, and how you can develop a similar process for your agency.

# THE MAGIC OF CERTIFIED PEER SUPPORT PROFESSIONALS

Peer support encompasses a range of activities and interactions between people who share similar experiences of being diagnosed with mental health conditions or substance use disorders.

A peer support worker is someone with the lived experience of recovery from a mental health condition, substance use disorder, or both. They provide support to others experiencing similar challenges. They provide non-clinical, strengths-based support and are "experientially credentialed" by their own recovery journeys, or both.

We will also travel down the intriguing path of the use of virtual and augmented reality for the rehabilitation of those with addiction as well as juvenile programs that are starting to see early promise in studies.

We will tie everything together by assessing which existing tools are poised to evolve into the future to provide the intelligence and information we will need to make accurate decisions regarding the management of program participants and why information will be the key to transformative success of criminal justice involved individuals.
